Isometric View



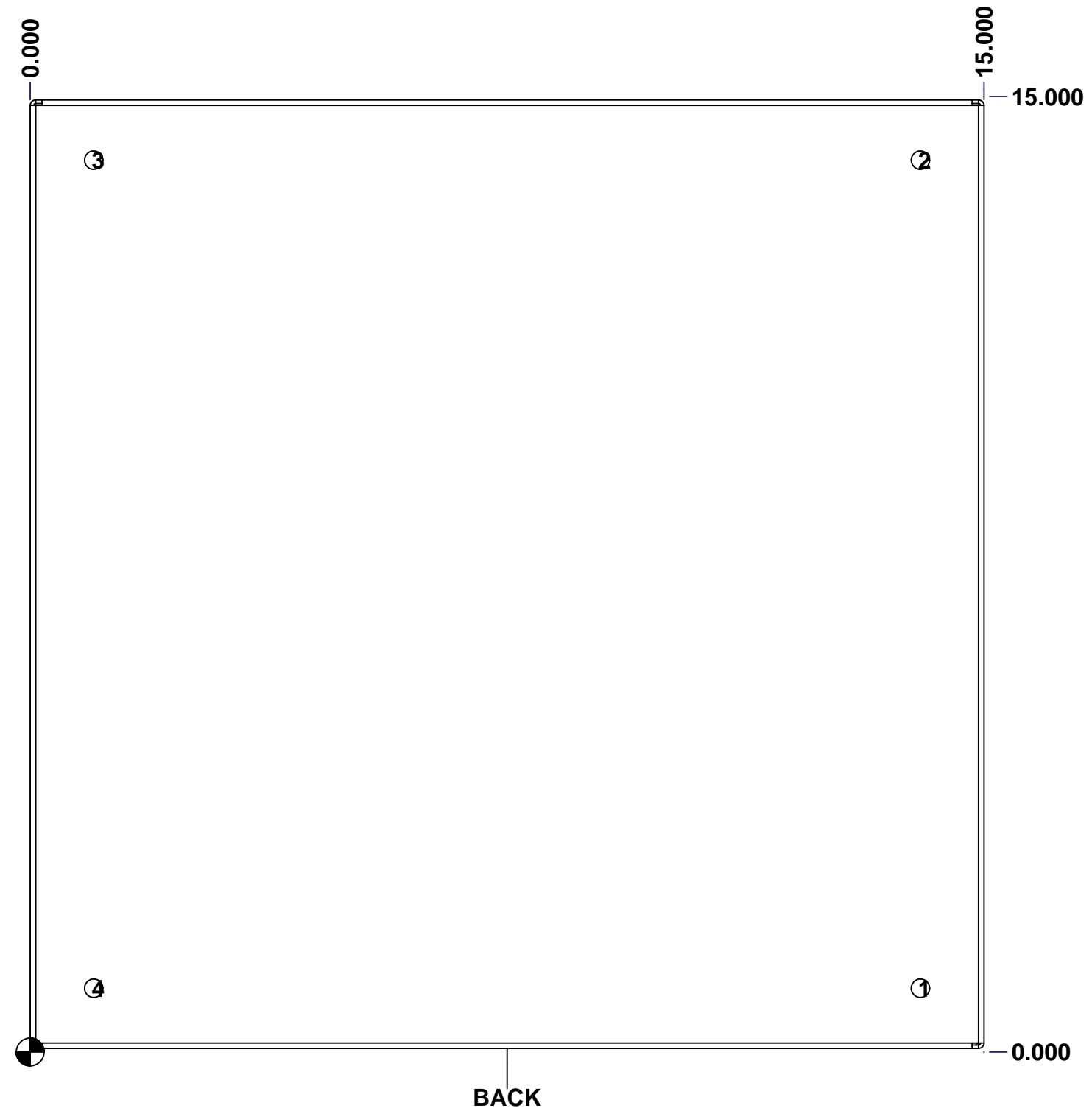
